Subject: Extending the Cut-off date for admission into PG courses (MD/MS) in ASU Collegesreg.

With reference to the subject mentioned above, I am directed to inform you that NCISM has notified 22nd March as Cut-off date for admissions into MD/MS courses in ASU colleges for the academic session 2021-22 (vide letter no. BOA/Academic Calendar/7-20/2022 dated 19.01.2022). Subsequently the cut-off date has been extended from 22nd March 2022 to 31st March 2022 (vide letter no. BOA/Academic Calendar/7-20/2022 dated 01.02.2022).

On receipt of representations from various state governments as well as colleges, the matter was discussed in the 11th meeting of NCISM held on 22nd March 2022. As per the decision of the 11th meeting of NCISM, the Cut-off date for admission into PG courses (MD/MS) in ASU Colleges for academic session 2021-22 has been extended from 31st March 2022 to 23rd April 2022. However , rest of the schedule prescribed in the tentative academic calendar will remain the same.
